# **PRINCIPAL'S REPORT:** Mr. Engelman presented on the following:

- A special Thank You to Brian Hansen from D Construction for providing the equipment needed to roll the boys baseball field
- The GSW HS Book Club took a field trip to see a movie about a book they read "Five Feet Apart"
- GSW Student & GAVC Criminal Justice student, Andreanna LaFaire, is going to attend a week long Police Academy in June.
- April 9<sup>th</sup> was testing day SAT and PSAT for Freshmen, Sophomores and Juniors and then the afternoon was CRP/AED training for the teachers, staff, coaches.
- GSW completed our 2<sup>nd</sup> intruder drill with the Grundy County Police.
- April 17<sup>th</sup> GSW completed 2 Fire Drills.
- PBIS Matrix Theme of "Dependable" 47 students were nominated by teachers.

**STUDENT HAND BOOK:** Mr. Engelman met with a committee of students, a parent, and teachers to review changes to the existing handbook. Mr. Engelman presented the changes to the board members at tonight's meeting. The changes included adding wording to the existing Tobacco section (Juules, vapes, cartridges) and removing some wording (curfew violation) that was out-dated.

**RENEWAL OF SERVICE AGREEMENT FOR INSPECTION OF FIRE ALARMS:** No increase this year. Johnson Controls comes out to GSW HS and does yearly system tests, but does not replace any equipment.

**ENERGY CONTRACT:** GSW plans to continue using Next Era Energy. Renewable with the Illinois Energy Consortium (Energy Brokers). GSW and other schools around the state use this resource to broker the best electric costs for us.

**TRANSPORTATION CONTRACT:** GSW HS did not put out for bid for transportation. GSW plans to continue using Illinois Central School Bus. There will be an increase of 3% for a 1-year contract.

**REPAYMENT OF INTERFUND LOAN:** Approve the repayment of the balance of an inter-fund loan as initially approved at the June 21, 2017 open meeting of the GSW Board of Education. Approve transfer of funds as repayment of \$20,000 to the Working Cash Fund (Fund 70) from the Transportation Fund (Fund 40). As presented in the FY19 Budget.

**OTHER ITEMS:** Pam Brooks, Board President, informed the board that she and Mr. Engelman, Principal, attended the Dwight High School board meeting that was held on Monday night, April 15<sup>th</sup> at 6:00 PM. They were present for the voting to disband the Dwight - GSW Football co-op. She stated that she was very proud of our GSW students and how they spoke publicly.
