

## Student Contract for GAVC

You have signed up for the opportunity to attend the Grundy Area Vocational Center. This wonderful opportunity can teach you many valuable life skills and we encourage you to make the most of this experience. Please understand that attendance at GAVC is a privilege, not a right. In light of that, please be aware of the following:

1. When you exit the building to attend GAVC, you do so as a representative of GSW High School. You are expected to conduct yourself as a mature, young adult. You may be removed from GAVC, if your behavior warrants such action. If you accumulate three (3) discipline referrals at any point during your GAVC experience, you will be removed from the program and will not be allowed to attend GAVC in the future. If your behavior poses a safety or security concern for GAVC, you will be removed from the program immediately.
2. The GAVC experience begins as you depart from GSW and includes the bus or car ride to and from GAVC.
3. Academic success in your coursework will be evaluated at the end of each semester. If you are failing GAVC at the end of the semester one, you may not be allowed to attend GAVC for semester two. If you fail semester two of GAVC, you will not be allowed to return to GAVC the following school year. If you are failing a course at GSW, you will not be allowed to attend GAVC the next school year. Instead you will be placed in coursework at GSW.
4. **If you are removed from GAVC you will also be responsible for reimbursing GSWHS District 73 for the GAVC tuition expense which is approximately \$2,200.00.**
5. **A student may accumulate 15 absences throughout the school year. Any additional absences without medical documentation are considered to be unexcused. Unexcused absences do not allow for students to makeup work. Students with excessive absences may be removed from GAVC and will be responsible for reimbursing GSWHS District 73 for the GAVC tuition expense which is approximately \$2,200.00.**
6. Early Bird students, Cosmetology students, Early Childhood Education, and students attending the Coal City, Reed Custer, and WILCO campuses must provide their own transportation. Early Bird classes begin in Morris at 6:45 am. Students are expected back at GSW in time for their 2nd hour class which begins at 8:58am. Early Bird is denoted on the student schedule as period 1. Students attending GAVC in the afternoon will return at approximately 3:20 pm. There is no bus service from GSW when the afternoon GAVC students return, however, students in sports will have transportation with the regularly scheduled bus transporting the rest of the team members on days which off-campus games or practices are scheduled.
